- use newer references. most of the references used in the manuscript are old.

- make the context more coherent and avoid information repetition.

- insert a table that illustrate the differences among the types of the conversation strategies and provide example for each which would be easier for readers to understand.

- when state the purpose of the study use the present tense of the verb. Do not use the future tense.

- in the methodology. you should determine the type of the qualitative approach being used in the study. eg. content analysis. and explain this approach.

state the setting of the study. where did the study take place?

- identify the type of sampling used in the study.
- explain the content and the structure of the observation instrument used in collecting the data.
- correct the spelling, eg: the word " Analysis"

- No research questions and clear research problem stated. you should take this into consideration.

- more in depth details is needed in the discussion and conclusion sections.
