GENERAL EVALUATION

What is the scientific soundness of the investigation; which is the significance of the content; what is the overall merit of the research?

We also recommend to argue on the thesis of the paper, we highlight its value. Including a paragraph presenting the structure of the paper will facilitate the reading of the study.

LITERATURE REVIEW

Is the research based on an adequate understanding of the literature in the field; are relevant and actual references cited; how could the body of sources be improved?

This section is not presented in the paper.

METHODOLOGY

Is the methodology appropriate to the objectives; are the methods properly presented?

We recommend to clearly present the objectives of the research and to argue on their relevance. The limits of the investigation might also be considered.

FINDINGS

Are results presented clearly and analyzed appropriately; are the associated discussions related to implications relevant for researchers and practitioners?

The results are generally clearly presented, but they are not critically analyzed. More discussions, having in mind implications for practice could be considered.

CONCLUSIONS

Are the conclusions clearly presented and related to the results?

This section could be extensively re-written. Limits and future lines of research might also be considered. Comparing the main findings with the situation before the pandemic or evolutions in other countries would be welcomed. The paper should make the case for its value, both from an empirical and a practical perspective.

ORIGINALITY/ ADDED-VALUE

Is the added value of the findings accurately and thoroughly presented, considering both theoretical and practical frameworks?

The author(s) should argument much more on the added-value of the paper, for policy-makers, public administration, civil society and academia.
