TERMS OF REFERENCE INDONESIA – JAPAN FORESTRY INVESTMENT DIALOGUES 2022

Japan, 1-5 August 2022

A. Background

The Indonesian government has conveyed a long-term vision to develop a climate-resilient low-carbon development pattern in line with the Paris target called the Low Carbon Compatible with Paris (LCCP) scenario. In this scenario, it is expected that net zero emissions (NZE) will be achieved in 2060 or earlier. In the LCCP, the rate of increase in energy sector emission is slowed down while from the Forestry and Other Land Use (FOLU) sector, which was previously a net emitter, will turn into a net sink in 2030. Hence, Indonesia is now implementing a more ambitious program called Indonesia's FOLU Net Sink 2030. The program will be implemented through: (1) Protection of forests from deforestation and degradation; (2) Protection of forest degradation in concession areas; (3) Plantation Forest development; (4) Sustainable Forest Management (SFM); (5) Forest and land rehabilitation; (6) Peatland management; (7) Biodiversity Conservation; and (8) Biodiversity Conservation.

Strategies to achieve the Indonesia's FOLU Net Sink 2030 include: (1) Forest Area Gazettement; (2) Social Forestry; (3) Multi-business of Forestry Scheme; (4) Forestry Planning; (5) Termination of the New Business License Issuance on Primary Forest and Peatland; (6) Implementing spatial planning, providing guidelines for biodiversity conservation in the regions, and strengthening land administration; (7) Development of the Environmental Fund Service Agency (BPDLH); and (8) Strengthening supervision and law enforcement for handling land and forest fires.

Indonesia's FOLU Net Sink 2030 indicates the necessities of transformational changes which require mobilisation of domestic resources and international partnership, especially in financial supports and capacity development, as well as research and technological cooperation. It is estimated that the implementation of mitigation actions toward FOLU net sink until 2030 will reach about Rp. 239 trillion. Currently, most of the financial source still comes from state budget (APBN), which is far from enough. Indonesia views that research will play a key role in supporting the implementation of the FOLU net sink 2030, therefore research collaboration among institutions within the country and national institutions with international partners needs to be strengthened. On technology development, Indonesia will enhance the role of endogenous technology, at the same time seeks the opportunity for technology cooperation under the framework of technology development and transfer of the Paris Agreement and the Convention. Hence, Indonesia continues to mobilise international financial sources through bilateral, regional, and multilateral channels.

In relation to the needs for international collaboration to support the implementation of Indonesia's FOLU Net Sink 2030, one of strategies that can be taken by Indonesia is strengthening cooperation with Japan that has a long bilateral cooperation with

Indonesia. For example, Indonesia-Japan Project for Development of REDD+ Implementation Mechanism (IJ-REDD+) had been conducted in the period of 2013-2018 and some projects on how to address forest fires under the framework of JICA as well as ITTO is now being implemented or initiated in Indonesia.

As Indonesia's FOLU Net Sink 2030 is also designed to maintain and even improve economic performance of Indonesia's forest products, especially timber, the cooperation with importing countries such as Japan is also important to be strengthened. Indonesia is one of Japan's sources of wood products imports. From January to April 2022, Indonesia has exported more than USD 541.5 million value of wood products comprising panel, paper, furniture, woodworking, wood chips, pulp, craft, and veneer. Panel (plywood) took the largest share with USD 311.7 million (57.6%) and the smallest share was veneer, accounting for USD 1.86 million (0.34%), while wood chips' share was USD 17.8 million (3.29%). The figures show how important forest-based products for trade cooperation between Indonesia and Japan.

In Indonesia, since the merge between the Ministry of Forestry and the Ministry of the Environment in 2015, policies in managing Indonesia's forest areas are becoming more integrated and focused. The most recent regulation issued by Indonesia was the Job Creation Law (UUCK) in Forestry Sector focusing on simplifying procedures and overcoming bureaucratic obstacles. UUCK confirms the position of licensing as an instrument of supervision. UUCK also provides a way out of various deadlocks in regulatory disputes, the use of forest areas, as well as long-term consequences such as tenure conflicts. UUCK also provides clear confirmation of government policies that favour the community, both in the allocation of forest use and utilisation, as well as in terms of social forestry stability with clear land holding, as well as in structuring areas and area disputes, as well as policy which guarantees people and provides a way to resolve customary forest problems, including changes in the forest management system.

The implementation of UUCK also had an effect on forestry administration as regulated in Government Regulation (PP) 23 of 2021 and its derivative regulations. The regulation allows business actors to develop multi-business forestry where concession holders may develop business diversification in the forestry sector by integrating the use of areas as well as the utilization of timber and non-timber forest products. In addition, the use of environmental services in the multi-business forestry model can be part of climate change mitigation actions, in the land-based sector. Contribution of concession holders in climate change mitigation efforts can be done through activities that can reduce emissions and increase carbon sequestration and/or conservation of carbon stocks.

Indonesia is also now building a new capital called *Ibu Kota Negara* (IKN) *Nusantara*. The IKN will be a smart city that is forest-based and is a net zero emission city. The IKN Nusantara area covers an area of more than 256,000 ha, 75% of the area is planned to be a green open space with 65% being a protected area and 10% for food production. IKN Nusantara is developed with 100% clean energy. Furthermore, the core area of IKN Nusantara will consist of various mixed-use zones and environments that support the concept of "10-minute walk" and social connectivity. This area is also designed in harmony with nature, with a minimum of 50% green space. As many as 80% of trips are made via public transportation or population mobility and most importantly, 100% green space changes will be made for each building.

Recently, Prime Minister Mr. Fumio Kishida, held a Japan-Indonesia Summit Meeting with H.E. Mr. Joko Widodo, the President of the Republic of Indonesia, at the presidential palace where President Jokowi stated that Japan is a strong partner in achieving peace and stability in the region and that he hopes to make steady progress in cooperation projects between the two countries in various fields, including trade, investment, infrastructure and the maritime and fisheries sectors. This confirms that trust, friendship, trade, investment, and a spirit of partnership have enabled the

relationship between Indonesia and Japan to grow beyond economic and political ties. They also talked about the support of Japan to the development of IKN.

Considering the long-term relationship and cooperation in almost 65 years of diplomatic ties between Indonesia and Japan, the Indonesian Embassy in Tokyo, in collaboration with the Ministry of Environment and Forestry and other relevant parties, is designed some activities comprising dialogue, awareness raising and comparative studies about forestry cooperation between Indonesia and Japan, especially in promoting investment, trade as well as the implementation of Indonesia's FOLU Net Sink 2030. The activities will be packaged in an Indonesia – Japan Forestry Investment Dialogues (FID) and will be conducted on 1-5 August 2022 in conjunction with the Indonesia Friendship Day (IFD) that will be conducted by Indonesian Embassy in Yokohama on 4-6 August 2022.

B. Objectives

The main objective of the FID is to facilitate discussion between policy makers, business communities and academia in Indonesia and Japan on how to strengthen cooperation in investment, trade, technical supports and best practices in forest and forest product management. The specific objectives of FID are:

- Sharing information on the implementation of Indonesia FOLU Net Sink 2030 that will affect the forestry business in Indonesia and open new investment in new paradigm of forest management.
- 2. Sharing information on the implementation of UUCK to the Japanese public, especially government officials and investors.
- Explore the potential of the cooperation area in the development of Sustainable Forest Management in Indonesia, including sustainable timber and non-timber forest products.
- 4. Comparative Study on the development of IKN Nusantara as a forest city.
- 5. Supporting national policies in utilising environmental services such as water, biodiversity and landscape beauty, and increasing the production of NTFPs.

C. Expected Outcome

- 1. The implementation of Indonesia FOLU Net Sink 2030 can invite Japanese cooperation and investments.
- 2. The implementation of UUCK is informed and well-explained to the Japanese public, especially government officials and investors.
- The cooperation in the development of Sustainable Forest Management in Indonesia, including sustainable wood products, is strengthened.
- 4. Indonesia can learn from Japan in developing a forest city to establish IKN Nusantara and can invite Japanese investments to build IKN.
- Japanese public can support Indonesia's policies in utilising environmental services such as water, biodiversity and landscape beauty, and increasing the production of NTFPs.
