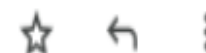

Please check and make corrections only on your chapter. Please send the files to me back by **10.6.23**.

As we will be proceeding straight to page proof, now is the time for you to catch any mistakes or make other changes. Changes in page proof are expensive and delay the book's publication date, so we cannot incorporate any major content changes after this point.

I have provided a few details below that will help you with the review of the copyedited chapters:

- Please note that we cannot accept a new version of your manuscript at this stage. Any amends you wish to make must be made in the copyedited files attached, or we will be unable to take them in.
- The copy editor has edited your files using Word's "track changes" function. Vertical rules in the margin indicate sections of the text where changes were made; new material will appear underlined, deleted material will appear with a strikethrough, and queries are included as comments.

- Please note that the copyedited manuscript has been “locked” to track changes, so that any changes you make to the text will appear on screen as underscored or struck through. You will not be able to use the “accept insertion/deletion” or “reject insertion/deletion” function. Please type your corrections and responses to queries directly into the file.
- If you find that you are making one particular type of straightforward correction frequently (a typical example would be correcting the spelling of a proper name that recurs frequently) then please make a note for a global change.

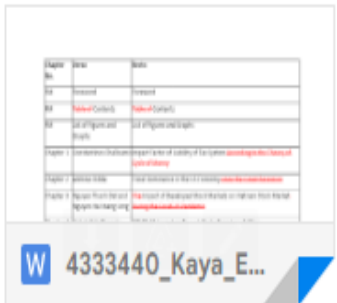

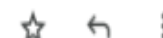
