Please do not use the words We or Authors in the text, but use the Passive Voice. The title of the article should be specified. You need to double the abstract at least twice. It should be written according to the following algorithm - relevance, purpose, method, result, conclusion. This is exactly the sequence it should be. In the first sentences, indicate which country you are talking about, which banks. Most of the volume of the abstract should be devoted to the result. The abstract should provide quantitative indicators of the demonstration of the results of the study. This sentence should be removed -COVID-19 has spread to approximately 178 nations around the world, infecting over 85 million people and causing over 1.8 million fatalities by 2020. This should also be removed - As a result of aforementioned issues, this study investigates the connection between the epidemic of COVID-19 and the stability of Indonesian banks by separating its core capital size and ownership. After making these edits, the manuscript will be accepted for publication.
